Cost Includes: Motor coach transportation, trail fees, and two nights' accommodations at the Holiday Inn Express near Munising with swimming pool, whirlpool, sauna, and free continental breakfast. *An optional Saturday group dinner will be offered. Evening transportation into Munising will also be provided for both nights.*

Trails: On Friday we will ski at the Brown County Reforestation Camp ski trails near Green Bay with 30 km of well-groomed trails and a chalet with snacks. On Saturday and Sunday we will ski at Valley Spur Ski Trail in the Hiawatha National Forest with 45 km of trails of well-groomed trails that are some of the most scenic to be found anywhere. Picturesque snowshoe trails are also available. The heated log cabin has snacks for sale. *Saturday is the annual "Taste and Glide" event (optional, about \$10 extra) to benefit Valley Spur and features food, such as chocolate-covered strawberries, at several stops along a beginner trail, as well as in the log cabin. All ski areas have both skating and striding trails for all skiing abilities.*
